In fact, studies have shown that these children are 3 times¹ more likely to suffer from intergenerational offending as compared to general population.

Intergenerational offending is not an easy challenge to crack. Established in 2018, NeuGen Fund ("NeuGen") focuses on supporting children and families of reformed offenders through various academic and pro-social initiatives under Neu Empowerment Model to prevent intergenerational offending.
